## Whiteboard Wisdom for Nonprofits

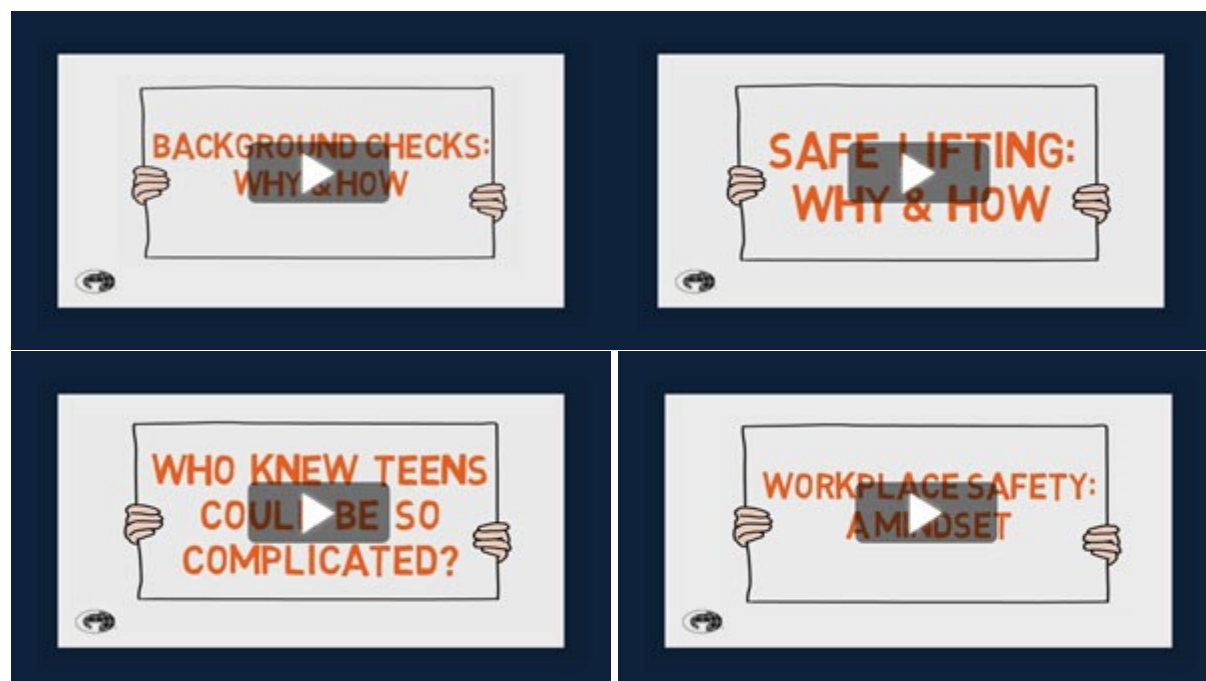
